- Two (2) exterior duplex GFIC electrical outlets (+1 @ each side of the exterior egress door)
- Two (2) exterior LED wall pack lights (+1 @ each side of the exterior egress door)

Question:

Is there a vendor information form on file for our company or will we need to fill this out and submit with the bid package?

Answer:

Per the RFP and the Request for Sealed Bids document, all submittals shall include a completed (up to date) vendor package.

Question:

For the demolition of the building, the survey report is inadequate. Just from the walk through, visually seen items that were left out of sampling/report and items that are unclear what exactly was sampled. i.e. ceiling tile, noticed several different types of ceiling tiles, but all the inspection report says is ceiling tile. If GA EPD or Federal EPA shows up during demolition, would get fined for not having proper test results. An asbestos inspection should be understandable by anyone reading it, have sample locations, clearly distinguish what items were sampled and provide the actual lab results.

1. Will price out the ACM work as listed in the report. If awarded (as a sub), and we perform an Asbestos inspection on the building, will there be any change orders if additional abatement items are discovered?
