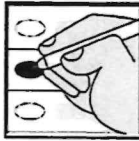

 SAMPLE BALLOT**

If you make a mistake or change your mind:

- A. Do not attempt to mark through a ballot.
- B. Mail or return the ballot to the poll manager.

When you receive a new official absentee ballot will be mailed to you.

If you decide to vote in-person: Surrender the ballot to the poll manager at an early voting site within your county or the precinct to which you are assigned. You will then be permitted to vote a regular ballot.
